The option contains an early-exercise provision and is exercisable as to unvested shares, subject to the Issuer's right of repurchase.
- The Reporting Person is a partner of The Column Group which invests through The Column Group II, LP ("TCG II LP"), Pono Capital, LP ("Pono LP") and Pono Capital II, LP ("Pono II LP," and together with TCG II LP and Pono LP, the "Funds"), among other entities. Under the partnership agreements of the Funds, the Reporting Person is deemed to hold the stock option for the economic benefit of the Funds. The Funds may be deemed indirect beneficial owners of the stock option. The Reporting Person disclaims beneficial ownership of the stock option except to the extent of his pecuniary interest therein.
